This release extends to any all claims I have or later may have against the "RELEASED PARTIES" resulting from or arising out of their performance of their event duties whether or not such claims result from negligence (except willful neglect) on the part of any or all of the "RELEASED PARTIES" with the respect to the EVENT (S) or with respect to the conditions, qualifications, instructions, rules or procedures under which the EVENT (S) are conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE "RELEASED PARTIES" FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF THEIR EVENT DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENT (S). I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I further agree to waive all benefits flowing from any state statues which would neglect or limit the scope of this Release and Indemnification Agreement, including but not limited to Section 1542 of the California Civil Code which provides: "A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this Release, which if know to him must have materially affected his settlement with the debtor."
